Upon approval, RIDOH will issue a final approval for licensure and/or operation. Please note that RIDOH may, in its sole discretion, determine upon future inspection that the construction/alteration does not appear to be in accordance with the conditions of the preliminary approval letter and/or (1) or (2) above. In this event, the applicant/licensee will be required to correct any and all deviations from the approved plan at the applicant's/licensee's expense.

Attestation
